

# TERMS OF SERVICE AGREEMENT

## ACCEPTANCE OF TERMS

Lil Munchkins Playground LLC does hereby reserve the right to cancel and cease offering any of the aforementioned Services and/or products. You, as the end user and/or member, acknowledge, accept and agree that Lil Munchkins Playground LLC shall not be held liable for any such updates, modifications, revisions, suspensions or discontinuance of any of our Services and/or products.
